Are you interested in increasing your professional credibility and being recognized for your abilities by becoming Certified in Erosion and Sediment Control?

In cooperation with EnviroCert International Inc. and the Northeast Chapter of the International Erosion Control Association, the Maine Nonpoint Source Training and Resource Center will sponsor an exam review course and subsequent exam for land use professionals and others employed in a field involving the control of soil erosion, who would like to become a Certified Professional in Erosion and Sediment Control (CPESC). The CPESC exam review course will be conducted on **March 31, 2010**, in Brewer, at Jeff's Catering and the exam will be held **April 28, 2010**, at the same location.

In order to be eligible to take the exam for CPESC certification, you must submit an application form to: EnviroCert International Inc. (address below) documenting certain educational and/or experience requirements, along with a resume, four letters of recommendation and an application fee.

To qualify you must have at least **7** years of professional level experience **or** have a BS degree or higher, in engineering, (agricultural, civil, or environmental) geology, soil science, natural resource science or management or a related field, **and 3** years of professional level experience.

If you are interested in becoming certified, you will need to access the CPESC website at: www.cpesc.org to obtain the necessary application materials.

The application materials must be approved by the CPESC Program's Application Review Committee prior to taking the exam. **Applications must be submitted to:**
